The following Annual Admission Notice has been prepared by the board of Faughart Community National School in respect of the admission of students to the school for the school year 2026/2027.

This notice was published on Friday 3rd October 2025.

Note: The figures set out below in relation to Junior Infants are subject to increase dependent on the overall student teacher ratio in the school at the time of the administration of the school's admission process for applications to the Junior Infant class.

All applications to the Junior Infants in Faughart Community National School will only be accepted from Friday 10th October 2025 and the closing date for receipt of applications is the Friday 7th November 2025. Applications received after this date will be considered and processed as late applications in accordance with the school's Admission Policy.

All transfer applications to Senior Infants, First Class, Second Class, Third Class, Fourth Class, Fifth Class or Sixth Class in Faughart Community National School will only be accepted from Monday 1st June 2026 and the closing date for receipt of applications is the Monday 22nd June 2026. Applications received after this date will be considered and processed as late applications in accordance with the school's Admission Policy.

Equally, any transfer applications received during the current academic year, i.e. before June 2026, to transfer into a class immediately, will be treated as a late application where the application window for transferring into the school for the academic year 2025/2026 took place during the previous academic year and anyone who did not receive a place at that time was put on a waiting list. Therefore, any available places that arise in that class during the 2025/2026 academic year will be filled from that waiting list, until that list expires at the end of the academic year 2025/2026.
